## Our framework to safeguard our community

Developed and implemented by i9 Education, the **i9 SafeSteps Framework** reinforces our responsibility to create environments where children are not only safe, but feel protected, valued, and at ease within our centres. It is our commitment to **shielding children, families, and educators** through proactive and consistent child safety practices.

Aligned with the Victorian Child Safe Standards, the i9 SafeSteps sets a clear framework for embedding inclusive, accountable, and vigilant practices across all our centres. It shields our entire community by guiding how we respond, support, and continuously improve – ensuring child safety is not just upheld, but championed in everything we do.



## C.A.R.E

Structured around nine core focus areas and inspired by our CARE values: **Create, Aspire, Respect, Empower**. The i9 SafeSteps Program is our organisation-wide commitment to creating environments where children feel safe, heard, and supported every day.

We firmly believe that achieving genuine child safety requires collaboration at every level. This means management is working closely with educators, families, children, regulatory bodies, government, and the wider community, ensuring that **no blind spot is left unchecked**.

# i9 Child Safety Framework

9 Strategic areas, implemented across all our centres:



## Leadership & Culture

Embedding a child-safe culture at all levels through visible leadership, values, and governance.  
(Covers CSS 1 & 2 and QA 1 & 2)



## Policy & Code of Conduct

Robust, clear policies and behaviour codes setting expectations for all staff and stakeholders.  
(Covers CSS 6 and QA 6)



## Safe Workforce Practices

Recruitment, screening, onboarding, and performance monitoring centred around child safety.  
(Covers CSS 7 and QA 7)



## Ongoing Risk & Practice Review

Continuous improvement via audits, feedback loops, compliance checks, and reflective reviews.  
(Covers CSS 10 & 11 and QA 7)



## Education, Training & Awareness

Regular training for staff and volunteers on obligations, child abuse indicators, and safe practices.  
(Covers CSS 8 and QA 7)



## Reporting & Complaints Handling

Accessible, confidential, and well-understood procedures to respond to incidents and concerns.  
(Covers CSS 9 and QA 2)



## Cultural Safety & Inclusion

Proactive, respectful communication and inclusive involvement of families and communities.  
(Covers CSS 5 and QA 5)



## Family & Community Engagement

Proactive, respectful communication and inclusive involvement of families and communities.  
(Covers CSS 4 and QA 4)



## Child Empowerment & Participation

Children are heard, included, and taught protective behaviours through curriculum and day-to-day interactions.  
(Covers CSS 3 and QA 3)
